CARRIERS RESPONSIBILITY CEASES AT <POD>" 1.Cargo in transit is accepted at first discharge port only, Intermodal is not accepted. 2.For destination HOCHIMINH, only accepted if shipment arrives on feeder call HOCHIMINH directly 3.If there are multiples containers, in transit clause must be repeated for each container. 4.Either Consignee or notify party have to be a Vietnamese Entity
